## **RULES / REELS 2019**

1. Pigeons may be entered into the Benzing Cradock Community Lofts (BCCL) at R250+R500 per entered pigeon.
  - Duiwe kan ingeskryf word in die BCCL teen R250+R500 per individuele duif.
  
2. R250 Perch deposit per entered pigeon must be paid on delivery. All pigeons not paid in full before the first Race will be put up for sale without further notice.
  - 'n R250 deposito per ingeskrewe duif moet betaal word met aflewering. Alle duiwe wat nie teen die eerste wedvlug ten volle betaal is nie sal sonder verdere kennisgewing verkoop word.
  
3. R500 Entry Fee per entered pigeon payable before 1<sup>st</sup> June 2019 after tosses or before the 1<sup>st</sup> Hotspot. All pigeons not paid in full before the first Race will be put up for sale without further notice.
  - R500 Entry Fee per ingeskrewe duif moet betaal word voor 1<sup>st</sup> June 2019 of na oefen vlugte of voor die 1<sup>st</sup> Hotspot. Alle duiwe wat nie teen die eerste wedvlug ten volle betaal is nie sal sonder verdere kennisgewing verkoop word.
  
4. Every entrant must make their own arrangements and pay all costs to get their pigeons to the loft or bought at auctions.
  - Elke deelnemer is verantwoordelik vir die reëlings sowel as koste om die duiwe by die hok te besorg of gekoop by veiling.
  
5. Yearlings to be rung with officially recognized 2018/2019 rings. No pigeons previously entered into the loft will be accepted for the Yearling competition.
  - Jaaroud duiwe moet toegerus wees met offisiële 2018/2019 ringe. Geen duiwe wat vantevore ingeskryf was in die BCCL sal aanvaar word vir die Jaaroud kompetisie nie.
  
6. The BCCL is indemnified against any claims as a result of injuries, death or loss of pigeons during the care, training and racing of the pigeons.
  - Die BCCL word gevrywaar teen eise in verband met beserings, vrektes en verliese tydens die versorging, oefening en wedvlugdeelname van die duiwe.
  
7. Any person visiting the loft premises will do it on his own risk, and will not be able to claim for any loss, damage or injuries against the loft.
  - Enige persoon wat die hokperseel besoek doen dit op eie risiko en sal geen eise vir enige verlies, skade of beserings teen die hok kan instel nie.
  
8. No fancier or any other person other than the loft management will be allowed in the loft.
  - Geen deelnemer of enige ander persoon behalwe die hokbestuur sal in die hok toegelaat word nie

9. Pigeons entered in the loft become the property of the loft and will be disposed of at their discretion.

10. Pigeons may be replaced at the fanciers own cost up to 28<sup>th</sup> February 2019.

11. No entry fees will be refunded.

12. Prizes as advertised are guaranteed if 500 or more paid pigeons in the Yearlings.

13. All prizes will be paid within 4 weeks after the auction.

14. Entries accepted in the BCCL from October 1st 2018 to February, 28th 2019.

15. The management of the loft will issue regular reports of training flights and the races. Full details, time clocked, number of pigeons and owner's name will be published. Results available on the website [www.cradocklofts.co.za](http://www.cradocklofts.co.za)

16. The best 50 Average birds + 6 Hotspot 3 places + 1<sup>st</sup> 10 in finals as well as all prize winners will be auctioned after the main race (if not entered into the Opens) The money of pigeons sold for more than R500 each will be divided 50% to the loft administration and 50% to the fancier after auction costs. Every entrant must supply a pedigree or information on the strain of the family of his pigeons on auction in order to be entitled to this kickback

17. If not sold on the auction all pigeons in the loft will be sold out of hand, for the loft owner account only. or buy them back. Inform management within 1 weeks after finalization of the final. (Preferably by SMS or e-mail.)

- Duiwe wat nie die veiling haal nie, sal na goeddunke uit die hand verkoop word vir die hokeienaar se rekening. Eienaars het die keuse om hierdie duiwe oor te plaas na die Opes of terug te koop. Laat weet die hokbestuur binne 1 weke na afhandeling van die finaal (verkiesfik deur SMS of e-mail).

18. At all times a decision taken by the BCCL committee will be final and binding and no variation in any respect will be permitted.

-Die besluit van die BCCL kometee sal finaal en bindend wees en geen afwyking sal toegelaat word nie.

19. The racing program will consist of 6 Hotspots + Final.

-Die wedvlug program sal bestaan uit 6 opeenvolgende wedvlugte + Finaal.

20. Weather permits all races will take place on Saturdays accept the Final will be on a Friday. However, management reserves the right to postpone a race at their discretion for the sake of the welfare of the pigeons.

-Indien die weer dit toelaat sal alle wedrenne op Saterdag plaasvind maar die Finaal sal op 'n Vrydag plaasvind. Die bestuur behou egter die reg om ter wille van die welsyn van die duiwe 'n wedvlug na goeddunke uit te stel.

21. If an electrical or other problem with the clock occurs, management will decide on the continuation of the race.

-Indien die klokstelsel om enige rede foutief raak, sal die bestuur besluit of die wedren in aanmerking geneem word.

22. In the case where a pigeon on return from a race, does not register that pigeon will be deemed not basket. No catching of pigeons and dragging over antennas will be allowed.

-In die geval waar 'n duif by terugkeer na die wedvlug nie registreer nie, sal die duif ge-ag word om nie gemandjie te wees nie. Geen duiwe sal gevang en oor antennas gesleep word nie.

23. When two or more pigeons clock at precisely the same time, the pigeons will share the highest position. The sum of the prize money for the separate positions will then be shared by the pigeons sharing the position. For example two birds enter the loft at the same time at

first and second. The prize money for first and second will then be divided and shared by both owners. The next bird will then be third.
